



**MEMORANDUM OF AGREEMENT

and

Universiti Malaya which for the purpose of this Memorandum of Agreement is represented by **Faculty of Business and Economics** (FBEC UM), located at 50603, Kuala Lumpur, Malaysia, is represented herein by its Dean, Professor Dr. Yusniza Binti Kamarulzaman and shall include its lawful representatives and permitted assigns of the second party.

FEB UB and **FBEC UM** shall hereinafter be collectively referred to as "The Parties" and individually as "The Party", where the context so requires.

Whereas:

- (1) Parties agree to cooperate on academic programs based on equality and reciprocity;
- (2) Pursuant to prevailing laws and regulations in their respective countries, as well as the procedures and policy of the Government of Indonesia and the Government of Malaysia concerning international collaboration on (academic research/ publication/ community service);

Therefore, Parties agree as follows:

Article One

Objective

The objective of the collaboration between parties are to promote mutual academic cooperation and exchange between two universities.

Article Two

Areas of Collaboration

(1) The Parties will jointly develop some or all of the following activities based on their respective academic and educational needs, such as:

1. Exchange of faculty members and students;
2. Exchange of academic literature and information;
3. Collaborative research;
4. Collaborative Community Service;
5. Joint Supervisor/ examiner;
6. Post-Doctoral Program;
7. Curriculum Review
8. Program “*Kampus Merdeka*” (<https://kampusmerdeka.kemdikbud.go.id/>) conducted by the following Study Programs in FEB UB:
 - a) Undergraduate Program in Accounting
 - b) Undergraduate Program in Management
 - c) Undergraduate Program in Entrepreneurship
 - d) Undergraduate Program in Economic Development
 - e) Undergraduate Program in Islamic Economy
 - f) Undergraduate Program in Banking and Financial Economy
 - g) Master Program in Accounting
 - h) Master Program in Economic
 - i) Master Program in Management
 - j) Doctoral Program in Accounting
 - k) Doctoral Program in Economic
 - l) Doctoral Program in Management
 - m) Doctoral Program in Management (Jakarta Campus)
 - n) Accounting Profession Program
9. Any other activities to be decided on the basis of mutual agreement by both universities.

Article Three

Methods of Cooperation

The implementation of each joint activity set out in this Memorandum of Agreement shall be negotiated and determined by both universities. Details of the implementation shall be set forth in a separate contract to be signed at the appropriate time by representative of both parties.

Article Four

Financial Provision

The terms and necessary budget for each program and project will be described in separate documents,

which will be prepared subsequent to this Memorandum of Agreement will be signed by both parties prior to the initiation of a cooperative program or project. A program may include one or more projects.

Article Five

Non-Binding Document

- a) This Memorandum of Agreement is not intended to be legally binding document. It is meant to describe the nature and to suggest the guidelines of the cooperation between the Parties as described above.
- b) Nothing shall diminish the full autonomy of either party nor will any constraints or financial obligations be imposed by either upon the other in carrying out the Memorandum of Agreement.

Article Six

Duration and Termination

- a) This Memorandum of Agreement is written in English and printed in two copies. The two universities shall keep one copy of the Memorandum of Agreement. This Memorandum of Agreement becomes effective upon completion of the signatures, valid for a period of five years from the date of signing.
- b) This Memorandum of Agreement may be terminated by any Parties upon issuing at least three (3) months written notice to the other Party prior to the termination date.
- c) This Memorandum of Agreement is subject to revision or renewal by mutual agreement.
