In consideration of the wish of the Faculty of Economics and Business and the Faculty of Administrative Science, Universitas Brawijaya, Indonesia and the Graduate School of Economics, Osaka University, Japan and to establish cooperation within the framework of the academic exchange with the aim of promoting mutual academic cooperation and exchange.

This agreement entered into by and between:

**Faculty of Economics and Business, Universitas Brawijaya** located at Jl. MT Haryono 165 Malang 65145, East Java, Indonesia represented herein by its Dean, **Abdul Ghofar, DBA., Ak.,** and shall include its representatives and permitted assigns of the first party.  
and

**Faculty of Administrative Science, Universitas Brawijaya** located at Jl. MT.Haryono 163 Malang 65145, East Java, Indonesia represented herein by its Dean, **Prof. Andy Fefta Wijaya,**

**Ph.D.**, and shall include its representatives and permitted assigns of the second party.

and

**Graduate School of Economics, Osaka University** located at 1-7, Machikaneyama, Toyonaka, 650-0043, Osaka, Japan represented herein by its Dean, **Prof. HIRAKIMOTO, Hiroya Ph.D.**, and shall include its representatives and permitted assigns of the third party.

**Whereas:** The Parties agree to cooperate on academic programs based on equality and reciprocity;

**Whereas:** Pursuant to prevailing laws and regulations in their respective countries, as well as the procedures and policy of the Government of Indonesia and the Government of Japan concerning international collaboration on academic, scientific, and research cooperation;

**Therefore,** in consideration of the above, the Parties have decided to enter into this Memorandum of Agreement which, from the date of its signature.

The Parties agree as follows:

### **Article One**

#### **Objective**

The objective of the collaboration between the Parties are to promote mutual academic cooperation and exchange between Universitas Brawijaya and Osaka University.

### **Article Two**

#### **Areas of Collaboration**

- a) The Parties will jointly develop some or all of the following activities based on their respective academic and educational needs, such as:
  - 1) Exchange of scientific material, publication, and information;

- 2) Joint conferences and academic program
  - 3) Joint research activity and publication
- b) This collaboration will be carried out by related study programs of Faculty of Economics and Business and Faculty of Administrative Science Universitas Brawijaya as follows:
- 1) Bachelor Program of Economics, Management, and Accounting;
  - 2) Master Program of Economics, Management, and Accounting;
  - 3) Doctorate Program of Economics, Management, and Accounting;
  - 4) Bachelor of Business administration, Taxation, and Tourism;
  - 5) Master of Business Administration;
  - 6) Doctor of Administrative Science.

### **Article Three**

#### **Methods of Cooperation**

The implementation of each joint activity set out in this Memorandum of Agreement shall be separately negotiated and determined by the Parties. Details of the implementation shall be set forth in a contract to be signed at the appropriate time by representative of the Parties.

### **Article Four**

#### **Financial Provision**

The terms and necessary budget for each program and project will be described in separate documents, which will be prepared subsequent to this Memorandum of Agreement will be signed by the Parties prior to the initiation of a cooperative program or project. A program may include one or more projects.

## **Article Five**

### **Security Export Control**

Both institutions agree to adhere to and comply with applicable export control laws and regulations. Both institutions agree that this academic exchange does not aim for design or development of military equipment, including but not limited to weapons of mass destruction. Weapons of mass destruction are defined as nuclear, chemical, biological weapons and missiles, and other unmanned aerial vehicles for military use.

## **Article Six**

### **Non-Binding Document**

- a) This Memorandum of Agreement is not intended to be a legally binding document. It is meant to describe the nature and to suggest the guidelines of the cooperation between the Parties as described above.
- b) Nothing shall diminish the full autonomy of either Party nor will any constraints or financial obligations be imposed by either upon the other in carrying out the Memorandum of Agreement.

## **Article Seven**

### **Duration and Termination**

- a) This Memorandum of Agreement is written in English. The Parties shall keep a copy of the Memorandum of Agreement. This Memorandum of Agreement becomes effective upon completion of the signatures, valid for a period of 5 (five) years from the date of signing.
- b) Either institution may, by giving six months' written notice to the other institution, terminate this agreement. However, termination of this agreement shall not affect the implementation of the collaborative activities established under it prior to such



termination.

- c) In the absence of any such early termination, the renewal of this agreement shall be discussed by both institutions at least 6 months prior to the natural termination of the current agreement.


